PROFESSIONAL & STAFF SERVICES

Basic Professional Fees

\$ 815.00

Professional consultation with licensed personnel, which may include but is not limited to, expert advice on options to meet your needs, including essential services relating to disposition, drafting notices, planning and scheduling of services, advising families regarding possible government benefits. A Basic Professional Fee is payable whenever we provide any services to you.

Co-ordinating Rites and Ceremonies

\$ 350.00

Co-ordination of all rites and ceremonies, before, during and after they have been provided, including services and supplies provided by us, as well as those provided by third party supplies, such as flowers and death notices.

Embalming of Remains *(requires facilities for preparation, embalming and shelter)*

\$ 465.00

Embalming is the process of replacing blood and bodily fluids with chemical preservatives. It is a process of sanitation, restoration and temporary preservation. Embalming is not legally required, but may be recommended to preserve the body between the time of death and the visitation or disposition of the deceased. Our professional funeral director(s) will make a recommendation based on the condition of the body and expected service needs. (If 48 will pass between time of death and time of final disposition, embalming will be recommended.)

Documentation – permits, forms etc.

Completion and filing of all documents necessary to carry out the services and supplies requested, including, but not limited to, death registration, burial permit, coroner's certificate for cremation, documentation necessary to ship the body out of the province or country. As part of this service, we will provide you with twelve (12) Proof of death certificates; such certificates are usually accepted for most estate settlement purposes, but sometimes a provincial Death Certificate will be necessary and is available from the Office of the Registrar General.

Basic Preparation of Remains *(requires facilities for preparation/ embalming/ shelter)*

\$ 350.00

The preparation of the body for placement into the casket, including bathing, dressing and the setting of facial features for identification or viewing without embalming.

Staff Services for Visitation

\$ 450.00

Staff to co-ordinate and oversee the visitation (informal gathering) at our premises or at a local hall or church for a period up to four (4) hours. *If the visitation takes place more than 50 km from the funeral home (Wawa), a travel charge of \$1.55 per kilometer will be charged. If the visitation is held a day prior to any services or ceremonies being held, a flat fee of \$825.00 (plus applicable taxes) will be charged to allow for overnight expenses, meals, travel time, staff coverage etc.

Unless otherwise identified, all applicable taxes will be added to the prices indicated.

Staff Services for Service/Ceremony \$ 500.00
Staff to co-ordinate and oversee the ceremony or memorial services at our premises or at a local hall or church. *If the ceremony is to be held further than 100 kilometers from the funeral home (Wawa), a travel charge of \$1.55 per kilometer will be charged.

Initial Transportation of Remains *(requires Initial Transfer of Remains Vehicle)* \$ 400.00
Vehicle, trained staff and specialized equipment used to transfer remains into our care from the place of death. (eg. home, hospital etc.) A charge applies for each transportation request.

FACILITY CHARGES

Basic Facilities \$ 700.00
Use of our general and common areas, parking lot, public washrooms, cloakrooms, heating, lighting and maintenance. This charge applies whenever we provide services to you.

Facilities for Preparation/Embalming \$ 295.00
Facilities used to prepare, embalm and/or shelter the body; this charge applies whenever the body is in our facility for any purpose.

Facilities for Visitation *(requires Staff Services for Visitation)* \$ 350.00
Designated facilities used for visitation for up to four (4) hours of visitation. Any additional time will be charged at the rate of \$125.00 per hour.

Facilities for Ceremony *(requires Staff Services for Service/Ceremony)* \$ 400.00
Designated facilities at our Funeral Home/Visitation Centre used for the ceremony or memorial service. This rate is a flat fee for the duration of the ceremony.

VEHICLES

Initial Transportation of Remains Vehicle *(requires Staff for Initial Transportation of Remains)* \$ 300.00
The initial transfer of the remains from the place of death to the funeral home within 100 km. If further than 100 km, a charge of \$1.55/km one way.

Funeral Coach \$ 350.00
Used to transport the body in a casket or in an urn in the urn ark.

General Purpose Vehicle \$ 350.00
This includes and is not limited for use to obtain and acquire all necessary permits, make arrangements with clergy/celebrants, flowers, cemetery and/or crematoriums.

FUNERAL STATIONERY \$ 295.00
Funeral stationery includes the provision of our standard package. This includes a register book, 50 acknowledgement cards, 100 themed coloured memorial cards, religious supplies and a presentation box.

*CREMATORIUM TRANSFER CHARGE	\$ 780.00
This charge is based on mileage to and from the crematorium and waiting time while the cremation process is completed. (This fee has remained the same prior to 2009).	
*OUT OF TOWN SERVICE CHARGE	\$ 825.00
This charge is based on the extra costs of staff coverage while our Director (s) and/or staff is out of town (100 km outside of Wawa) as well as additional expenses incurred for their out of town accommodations and meals. (This fee has remained the same prior to 2009).	
*SPRING INTERMENT FEE	\$250.00
This fee may apply when a Spring Interment is necessary. This is to cover the cost of staff requirements. Mileage may be charged if the interment is more than 100 km from Wawa. If a lowering device is necessary, additional charges may also apply.	
*EXTENDED STORAGE FEE	\$95.00/day
This fee applies when a body needs to be held at the funeral home due to any delays in making arrangements until the final disposition has taken place.	
*SERVICES ON WEEKENDS/STATUATORY HOLIDAYS/AFTER 30 DAYS	
Additional fees will apply. All services will be charged @ the rate of 1.50 in addition to the regular fees. Also, any services held beyond 30 days from the date of death will be subject to additional fees.
